De La Rue Archives show that they quoted on 30 December 1895 for the printing of envelopes with 1d, 2d and 2½d letterpress stamps. The envelopes were delivered by Waterlow & Sons in sheets to De La Rue for stamping. The records provided to the Agent General set out the numbers of each envelope delivered and final delivery did not include a 1d envelope. The envelopes were delivered to the Agent General (Sir Westby Percival) on 7 September 1897 and received in Hobart on 4 December 1897.

The Agent General noted the 'very strong objections' received that the illustrations left very little space for the address. H Buxton Forman of the General Post Office, London in a letter to Sir Westby Percival stated in part '...In this country it has been found necessary to stipulate that at least one half of the address side of a letter should be reserved for the address, postmarks etc. Excellent as the drawings are, their reproduction on envelopes intended for the post would be regarded as impractical...'










## 8.2 Printed Messages on Tasmanian postal stationery



The utility of printed messages on postal stationery was well established by the time Tasmania issued their first postal card in 1882. It is no surprise, therefore, that the earliest examples of commerce using the postal card to advertise their merchandise or meeting is found on the 1882 lithographed post cards.

The practice was adopted by commerce, especially the numerous speculative mining companies established from 1885 to 1899. They required regular communication with shareholders concerning calls on shares and notices of meetings. Many associations, clubs, religious organizations and sporting clubs used this method of notifying meeting dates. Businesses advertised their products and this method of communication was ideal for the travelling salesmen who visited Tasmanian rural areas, especially visiting from the mainland. Shipping companies notified customers of sailing dates and the expanding apple industry gave rise to cards confirming apple consignments and prices.

A number of users produced different messages and they have been consolidated under one name.

These messages provide an insight into business and social activities of the Colony from 1882 to 1913. Examples of messages are recorded on all issues of the 1d post card, the 1½ d Reply card, letter cards and on the 1d Commonwealth postal card issued to commemorate the Coronation of King George V.
